- I. MEETING CALLED TO ORDER: By Honorable Mario Avery.
- **II. ROLL CALL:** All Members of Council were present which constituted a quorum.

### V. PUBLIC COMMENTS:

1. Andrew Whitmore, 25 Somerset Hills, Fairburn, GA. Homeowners Association President and Vice President of the Executive Board, represented the Parks at Durham Lakes. He spoke on the reduction of the 255 lots in the new Brookhaven Community. He said he spoke with the City Administrator and the City Engineer and was not informed about the plat reduction. He said the plat was approved in May 2008 and some of the plats are now being taken away. He asked who gets to benefit from this project and why would the City negotiate with investors. He asked why the Homeowners Association should get an Attorney when they have a legal document stating there are 255 lots at the time of purchase of the investors. He said he find it appalling that the City would use density as a reason to reduce the lots without communicating with the Homeowners Association. He said there are 255 lots and the average cost per lot is \$10,574.00 which is a total of 2.6 million dollars. He asked the City to

consider working with the Homeowners Association.

- 2. Horace Cooper, 880 Buckingham Cove, Fairburn, GA. thanked Sergeant Bazydlo and the Chief of Police for assisting them with the Herron Woods Community. He said Herron Woods has gang members who have moved into the community and they are coming into Durham Lakes and the Parks at Durham Lakes. He asked for assistance from the Mayor and Council and the Fulton County Commissioner to rectify the issue.
- **3.** Lorre Daniel, 16 W. Campbellton Street, Fairburn GA. announced the opening of her new business, Southern Cosmopolitan Baking Company located behind Oz Restaurant at 16 W. Campbellton Street, Fairburn GA. She said they are looking forward to working with everyone and being a part of the community.
