- I. MEETING CALLED TO ORDER: Honorable Mayor Mario Avery.
- **II. ROLL CALL:** Council Members Alderman, Glaize, Heath, Johnson and Portis-Jones were present. Council Member Hurst was absent.
- **III. INVOCATION:** provided by Mayor Mario Avery.
- IV. PLEDGE OF ALLEGIANCE: was recited in unison.

V. PUBLIC COMMENTS:

- 1. Gerald Todd, 300 Rivertown Road Fairburn, Georgia addressed his concerns with the City Zoning Ordinance. He spoke on the proposed event center located at 49 Main Street. He requested Mayor and Council consideration on issuing a temporary license to allow the business to open.
- 2. Danise Churchwell, 41 S.W. Broad Street, Fairburn, Georgia spoke on obtaining a Business License and a Special Use Permit to conduct business at 49 Main Street.
- 3. Andrew Whitmore, 25 Somerset Hills, Fairburn, Georgia addressed his concerns with how Family Dollar is using the recycling bins to get rid of cardboard boxes. He said the pool will be a great attraction for the citizens of Fairburn.

- 2. John Long, 2572 Brookdale Drive, spoke in favor of the ordinance. He said he is one of the partners working on the project. He stated there will be 308 units constructed with 60% of the units being one bedroom and 40% will be two bedrooms. The price range will be between at \$850 to \$1,100. Some of the amenities will include granite, stainless steel, fitness club and a coffee bar. There were no speakers against.
