- I. MEETING CALLED TO ORDER: By Honorable Mario Avery.
- **II. ROLL CALL:** All Members of Council were present which constituted a quorum.
- III. INVOCATION: Provided by Council Member Lydia Glaize
- IV. PLEADGE OF ALLEADGENCE: Recited in unison.
- V. **PRESENTATIONS AND AWARDS:** Mayor Avery read a Proclamation for Mother Mozell Jenkins into the record.

# PROCLAMATION Mother Mozell Jenkins

Whereas, It is appropriate that the City of Fairburn recognize a City of Fairburn resident who has lived for 90 years;

# IX. APPROVAL OF THE COUNCIL MINUTES: Minutes of August 25, 2014

Council Member Hurst made a motion to approve the Minutes of August 25, 2014 with one correction made by Council Member Johnson, on page 7: under Council Member Johnson's comments, change the word ran to run. Council Member Alderman provided the second. **The motion carried.** 

#### X. PUBLIC HEARING:

**1.** Zoning Text Amendment: Article XIV, Sec. 80-477. Fence Ordinance (TA-2014-13)

City Planner Toussaint Kirk gave an overview of the Zoning Text Amendment: Article XIV, Sec. 80-477-Fence Ordinance (TA-2014-13). He said this ordinance was omitted when changes were made in 2012.

Mayor Avery opened the Public Hearing:

He asked to hear from those against and in favor of the Ordinance.

#### **Spoke Against:**

No one came forward.

#### **Spoke in Favor:**

No one came forward.

Mayor Avery closed the Public Hearing. Council Member Heath made a motion to approve the Zoning Text Amendment: Article XIV, Section 80-477- Fence Ordinance (TA-2014-13) with Council Member Glaize providing the second. **The motion carried.** 

## X. APPROVAL OF THE AGENDA ITEMS;

#### 2. Revision to Recreation Fee Schedule

Council Member Johnson made a motion to modify the fee schedule for Pavilion #3 to \$50.00 for residents and \$75.00 for non-residents with Council Member Glaize providing the second. **The motion carried.** 

3. Lease Agreement with GRASP, Inc. and Marnessa Vital for the Youth Center for the Fall Semester of the 2014-2015 Academic School Year

Council Member Heath made a motion to approve a 4 month Lease Agreement with GRASP, Inc. and Marnessa Vital for the Youth Center for the Fall Semester of the 2014-2015 Academic School Year in the amount of \$3600.00 with Council Member Alderman providing the second.

Council Member Portis-Jones asked about the funding issue and said she did not realize it was for one semester.

Ms. Marnessa Vital gave the background of the funding for the GRASP program. She explained they will receive \$35,000 for one semester and will know by the end of December 2014 if they will receive funding for the balance of the school year.

Council Member Glaize asked if they were going to receive \$35,000 for four months, why is there a need to reduce the price of the rent.

Ms. Vital explained the funds are used to pay the salaries of the four people on staff, to purchase the insurance policy and pay unemployment benefits.

Council Member Glaize said she is very empathetic but there is educational funding through the state. She said the City of Fairburn is not in the education business.

Council Member Hurst said she was reading the letter written to the Mayor and Council and it was said there would be a slight decrease in the funding. She said she read the program in great detail and she applauds GRASP for

the mediation skills and the bullying program.

Council Member Johnson said she feels the program is worth approving.

Mayor Avery asked Ms. Vital had she ever spoken with Commissioner Edwards about this program. She said no.

Council Member Glaize said she does support the program; however she is concerned about how much more the City of Fairburn can take on. She said they should get their own hardware because she does not want to see the City become a 9 to 3 educational provider.

Council Member Portis-Jones said she is impressed with the details of the program and she would like to offer her services as a citizen of Fairburn to help in any way she can.

Council Member Heath said he has dealt with juveniles and the children need guidance, so he thinks this program will be a great one for them.

After much discussion, the motion carried.

## XI. MAYOR AND COUNCIL COMMENTS:

Council Member Portis-Jones had no comments.

Council Member Johnson had no comments.

Council Member Glaize said South Fulton has a 50% graduation rate and there are many in our city who did not graduate from high school. They need a GED to become employed. She said she is strongly conservative with the spending of city funds. She said she has asked and encouraged the city to look for grants to be used in our city.

Council Member Hurst said Andrew Whitmore lost his mother and asked everyone to keep him in their prayers. She told Ms. Vital that she is willing and able to be of any assistance to the GRASP program.

Council Member Heath said we must take care of our youth, because if not they will get into drugs and gangs.

Council Member Alderman had no comments

Mayor Avery said there will be a workshop on Thursday, at 6:15p.m. He welcomed the new City Engineer and thanked Herbert Humphrey and Anthony Brown for helping us during the interim. He also thanked Council Member Glaize for recommending the proclamation for Mother Mozell

Jenkins.

Council Member Alderman made a motion to recess into Executive Session at 8:10p.m. to discuss pending litigation and a real estate matter with Council Member Heath providing the second. **The motion carried.**
