II. Approval of Minutes:

Ms. Appleby made a motion to approve the Minutes of April 30, 2013 for the Downtown Development Authority Meeting with Mr. McCarthney providing the second. **The motion carried.**

Mr. Appleby made a motion to approve the minutes of May 22, 2013 for the Special Called Meeting of the Downtown Development Authority with Mr. McCarthney providing the second. **The motion carried.**

III. Update on Economic Development Activities:

City Administrator, Tom Barber gave an overview of the downtown development activities. He reported the following:

- 1. The Campus Parking Lot upgrade is currently underway.
- 2. The building of the Campus Classroom Building is underway. However, there is no lease yet with GMC for the new building.
- 3. The Design for the Courtyard and Stage are completed.
- 4. Still waiting on Paul Marmol regarding the deck.
- 5. There has been interest in the Roberts Building & the Patrick Green Property.
- 6. The Convention Center will be developed and the company has completed 50 to 60% of their fundraising.
- 7. Strawn Brewery 1st Year Anniversary is September 7, 2013.

IV. Presentation on Planning Activities, Comp Plan & Urban Redevelopment Plan:

City Planner, Toussaint Kirk gave a brief overview of himself. Afterwards he spoke on the City of Fairburn's Comprehensive Plan. He said a Comprehensive Plan is a 20 Year Policy Guide for the development and redevelopment of the city. He said the plan should be updated every 10 years, however, currently the City of Fairburn is working on a 5-year Partial Update and another plan will be done in the year of 2015. He said a Comprehensive Plan helps a city to receive other funding and it supports the zoning in the city. Mr. Kirk said the update will require extensive public participation.

Mr. Bill De-St-Aubin of the Sizemore Group spoke on a Fairburn Urban Redevelopment Plan. He said an extension to the LCI would be an Urban Redevelopment Plan, Enterprise Zone and Opportunity Zone and all these are tools to attract business to the City of Fairburn. He said to get an Urban Redevelopment Plan one must meet the State Criteria's. He said the URP has been presented to the Planning & Zoning Commission and must also be approved by the Mayor and Council. Mr. Couch asked what the benefits were. City Administrator, Tom Barber said the plan gives the city a better opportunity to go after the blighted areas. Mr. De-St-Aubin said other benefits consist of how the city can define and control the path to the Opportunity Zones, Job Tax Credits of \$3500.00, and powers to redevelopment with eminent domain; and bond financing.

Mr. Kirk distributed a handout on the Nuisance Abatement Program and said this program works well with the Urban Redevelopment Plan.
