## Development Authority's First Class Success

### Educational Campus Celebrates Grand Opening

The City of Fairburn hosted a Grand Opening on November 18, celebrating the first phase of Fairburn's Educational Campus for principal tenant Georgia Military College, a Liberal Arts Junior College.

The City's vision for the establishment of a strategically located campus within its Downtown Historic District has become a reality. The Grand Opening Celebration was another milestone along the way in this exceptional and unprecedented \$10 million project funded by the Development Authority and the City of Fairburn.

Mayor Betty Hannah, in her welcoming remarks noted, "Just nine short

months ago when we broke ground for the campus, I indicated the economic impact of this project on the citizens and the City of Fairburn would prove to be enormously beneficial. That impact is already noticeable according to several of our local retailers. Anchor tenant Georgia Military College moved in on October 13, with 78 full and part-time instructors and staff and an enrollment of 550 students from all over metro Atlanta. Classes are held everyday of the week. The addition of over 625 people to our city each week is true economic development."

Highlights of the day included the appearance of the GMC Drill Team and the Campbell Elementary School

Chorus. Music was provided by the Creekside High School and Bear Creek Middle School Bands.

Over 400 people attended the official opening of the campus. Featured speakers included Campus Director Deborah Condon, Major General Peter Boylan, President of Georgia Military College, Atlanta Technical College President Dr. Alveta Thomas and Georgia State Senator Ronnie Potts.

The four-acre campus will eventually consist of four 18,400 square-foot brick classroom buildings, an 11,400 square-foot administrative building and two 2,000 square-foot retail buildings.

## Main Street Program a Step Closer

The initial on-site visit by the Georgia Department of Community Affairs Office of Downtown Development (**ODD**) took place at City Hall on September 15. Martha Reimann of the **ODD** staff met with key stakeholders, the Mayor and members of City Council and the Downtown Development Authority to provide information and outline the steps in the process. A question and answer session followed. The meeting was a critically important first step for the City in moving forward in attaining Main Street status. Additional meetings will be scheduled for key stakeholders and members of the community. The Development Authority will be seeking a group of dedicated and supportive volunteers to assist in this effort. All citizens are encouraged to participate. It is of interest to note that investing in downtown development has returned some significant dividends statewide. **Since 1980, in Georgia Better Hometown and Main Street Cities, over 7,000 net new businesses and over 36,000 net new jobs have been created in cities under 50,000 in population, for a total public and private sector investment of over \$1.7 Billion!** That is reason enough for city leaders to continue to nurture the heart and soul of their city - its downtown.
