Tent Permit Requirements

All tent permits shall be issued by City of Fairburn Fire Marshal's Office and requirements shall be in accordance with the Current Editions of the International Fire Code, International Building Codes, Life Safety Codes, and Rules and Regulations of the Fire Commissioner as adopted.

2018 International Fire Code, Chapter 1, Scope and Administration. A 105.6.47 Temporary membrane structures and tents. An operational permit is required to operate an air-supported temporary membrane structure or a tent having an area in excess of 400 square feet (37 m2). (Building code 3103.1.1 Permit required greater than 120 square feet and are used for a gathering of 10 or more people). Exceptions:

- 1. Tents used exclusively for recreational camping purpose.
- 2. Tents open on all sides that comply with all of the following:
 - 2.1. Individual tents having a maximum size of 700 square feet (65 m2).
 - 2.2. The aggregate area of multiple tents placed side by side without a fire break clearance of not less than 12 feet (3658 mm), shall not exceed 700 square feet (65 m2) total.
 - 2.3. A minimum clearance of 12 feet (3658 mm) to structures and other tents shall be provided.

2018 International Fire Code, Chapter 31 Tents and Other Membrane Structures.

Section

3101.1 Scope. Tents and membrane structures shall comply with this chapter. The provisions of section 3104 are applicable to temporary and permanent tents and membrane structures.

3103.4 Permits. Permits shall be required as set forth in sections 105.6 and 105.7

3103.5 Use Periods. Temporary tents, air supported, air inflated or tensioned membrane structures shall not be erected for a period of more than 180 days within a 12 month period on a single premises.

3103.6 Construction Documents. A detailed site and floor plan for tents or membrane structure with an occupant load of 50 or more shall be provided with each application for approval. The tent or membrane structure floor plan shall indicate details of the means of egress facilities, arrangement of the seating and location and type of heating and electrical equipment.
