Letter from the City Administrator, Fairburn Addresses Water Concerns

Dear Fairburn Residents:

Providing best in class government services is an ongoing commitment of the city of Fairburn. In doing so, we value transparency and open communications.

In January of this year, the city was contacted by the GA Environmental Protection Division (EPD) about water monitoring violations that occurred in February and October of 2020. In both instances, the required number of water samples were not collected. When these violations occurred two years ago, Public Notice to residents was not issued as required by state ordinance.

In our ongoing efforts to be a transparent government and to ensure that the city complies with all EPD ordinances and requirements, residents will receive notice of the 2020 violations in their upcoming utility bills. The city has taken all appropriate steps to ensure that our water sample monitoring is in full compliance and that Fairburn's water supply is healthy and safe.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER Monitoring Requirements Not Met for Fairburn Water System

PUBLIC NOTICE

Our water system violated a drinking water requirement. Even though this was not an emergency, as our customers, you have a right to know what happened and what we are doing to correct these situations.

"We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During the compliance periods of 2/1/2020 to 2/29/2020 and 10/1/2020 to 10/31/2020, we did not complete all monitoring or testing for Total Coliform/ E. Coli and therefore cannot be sure of the quality of your drinking water during that time."

What should I do?

There is nothing you need to do currently.

What is being done?

We have since taken the required samples. The samples showed that we are meeting drinking water standards.
